Clinical Information System Integration One-off Practice Registration

## Introduction to Clinical Information System Integration

Before users can access the NCSR via clinical information system integration your PRODA Registered Officer/Responsible Officer must complete a one time registration process using PRODA and the National Cancer Screening Register (NCSR) Healthcare Provider Portal.

This guide outlines prerequisites and the steps required to complete registration.

# Pre-requisites to be completed in PRODA

#### Step 1:

Before commencing the NCSR registration process, check the following are complete:

Responsible Officer (must be an Associate or Authorised Person on the Australian Business Register) has an individual PRODA account

 <u>Services Australia PRODA – How to register for an</u> Individual account

Have your organisation's Healthcare Provider Identifier–Organisation (HPI-O) number ready. This must be the HPI-O that has been used to register for the organisation's National Authentication Service for Health (NASH) certificate. Most practices already have a HPI-O, however if required further details can be found at:

The Responsible Officer (must be an Associate or Authorised Person on the Australian Business Register) has registered their organisation in PRODA:

The Responsible Officer has linked the NCSR as a Service Provider to the organisation within PRODA.

If the person registering is a delegate of the Responsible Officer, they must have been delegated the relevant attribute delegation in PRODA. Specifically, the 'NCSR CIS Terms and Conditions' attribute must be delegated to the person registering.

Once the above are complete, proceed to step 2.

## Register your practice with the NCSR

#### Step 2:

Login to the <u>NCSR Healthcare Provider Portal</u> using your PRODA username and password and enter your two factor authentication code when prompted.

#### Step 3:

Upon successful login, **Link you account page** displays. Select - 'I would like to register a Practice using a practice management system or clinical information system using a HPI-O'.

#### Step 4:

Enter your HPI-O number and select Save, then Register.

Note: You may register more than one HPI-O by selecting 'Add HPI-O'.

#### Step 5:

The Register will obtain your organisation's ABN and business name from Services Australia, and display this on screen.

Confirm these details are correct, or modify and correct the information presented.

These details must match the organisation details in PRODA in order to proceed.

#### Step 6:

Complete the form, to record details for your organisation, Responsible Officer and alternate contact(s).

Select 'Continue'.

Step 7:

Read and accept the Terms of Use.

# Registration trouble shooting

Error	Trouble shooting
Organisation details entered do not match with our records	The organisation name and/or ABN does not match the PRODA organisation details. Confirm the HPI-O entered is correct, and aligns to the organisation name and ABN in PRODA. Contact the PRODA hotline for support – <b>1800 700 199</b>
Please resolve PRODA Service Attribute	The PRODA organisation does not have the NCSR linked as a Service Provider. Link the NCSR as a Service Provider or contact the PRODA hotline for support – <b>1800 700 199</b>
